### **Institutional Repository Policy**

USI seeks to promote the online dissemination of its own doctoral publications, on conditions that they have met with the approval of the Examining Committee and after all necessary revisions have been made. The aims are to facilitate access to knowledge, promote contacts and exchange with the academic community worldwide, and contribute to the recognition of USI scholars.

Although USI and the Author share thesis copyrights, the Agreement does not imply that USI renounces its own rights.

Rights granted to USI through this Agreement are non-exclusive. The Author retains the right to publish the Work elsewhere, either in its present or future versions, under his/her own responsibility. The Author agrees with the aims outlined by USI.

## **Terms and conditions**

1. The Author declares that the electronic version of this work is a true copy of the work approved by the thesis panel (all necessary revisions having duly been made) and object of legal deposit.

2. By signing this license, the Author warrants that he/she is the copyright owner.

The Author shall inform USI if he/she grants publication, dissemination or distribution rights to a third party.

The Author undertakes not to grant a third party any rights that may interfere with this Agreement. The Author retains the rights and obligations of this license in any future agreement.

3. The Author authorizes USI to mention the Work on any document (also electronic versions) by means of a brief abstract, if necessary, and to disseminate the Work via Intranet and Internet.

USI is under no obligation to make use of this authorization.

4. USI undertakes to ensure that the Author's name is appropriately cited and that copyrights as well as the 'unauthorized reproduction' warning message are clearly displayed.

USI is not liable for any misuse made by others (illegal copies, plagiarism, breach of any intellectual property rights or other rights, etc.).

USI is not liable for any breach of security affecting the systems employed for the online deposit of the Work. The Author renounces to sue USI for any hacking action made by others. The Author, however, is fully entitled to his/her rights against the offenders.

5. The Author authorizes USI to submit an electronic copy of his/her thesis to the Swiss National Library, in accordance with the latter's policy (art. 2 LBNS, 18 December 1992).

The Author also authorizes USI to adopt long-term preservation and access measures, if necessary in collaboration with the appropriate Swiss institutions (National Library, Consortium of Swiss Academic Libraries etc.)

6. The Author is responsible for the content of his/her own work and for acknowledging any reference to other works.

The Author declares that he/she has obtained all necessary acknowledgements or permissions by the copyright owners of the works which have been partially or totally reproduced (illustrations, multimedia excerpts, etc.)

7. The Author is responsible for any damage caused to USI resulting from a breach of this Agreement.

- 8.** The Author is entitled to revoke the license for internet distribution by informing USI in writing and by recorded delivery.

In this case, USI is obliged to remove the Work within a reasonable time, or before the next website regular update at the very latest.

The license for the intranet distribution expires after ten years. The Author may revoke the license by informing USI in writing (recorded delivery).

- 9.** USI has the right to remove the Work from its website and in the event, if possible, will inform the Author. For this purpose, the Author shall inform USI of any change of address.

The online distribution of the Work, as well as its removal, does not imply any evaluation or criticism of the content of the Work itself, nor does it entail any responsibility on USI's part to third parties in this regard.

- 10.** Any cost related to the authorized distribution of the work on the net is covered by USI. No payment is due to the Author on the grounds of this Agreement, with respect to the license herewith granted.

- 11.** This License is granted in perpetuity.

- 12.** Swiss law applies; Lugano is the place of jurisdiction.
